1. Welcome, Introductions and Administrative Remarks

Karan Hoffman and Rebecca Morrison from RTCA and Anna Guegan from Eurocae welcomed the participants. Anna and Karan presented the RTCA and Eurocae IPR and other relevant policies. Jean luc lead the roundtable table of introductions.

2. Agenda Review

The group reviewed and approved the meeting agenda (which Jean Luc presented).

3. Plenary discussions

The goal for the week were:

1) to resolve all the comments and achieve an agreement (on the resolution) in principle.

- 2) Review particular parts of the Guidance document that necessitates a larger update and a broader agreement (Executive summary, Section 5 caveats and simulation results, RSZ, Appendix SG2)
- 3) Decide on whether we needed an additional virtual plenary to release the guidance document.

Many comments have been tentatively resolved. Seth welcomes the commentors to review the preliminary resolutions and provide feedback on the same. This would allow the larger group to address the outstanding comments.

The plan for the meeting was for Dave and Seth to go through and address the outstanding comments against the DO-399 doc. Dave took the floor and started working the comments. He added that he had some initial discussions with commentors to help prepare closure of the comments. As part of the comments resolution, the SC-239 team carved out specific time windows through the week to help accommodate stakeholder schedules and addressed comments from stakeholders such as EASA, GSA etc.

There was further discussion around updating the executive summary and Andy Roy helped lead this effort. The team worked this action during the meeting and shared it back with the commentors to obtain their feedback on the same.

There was further discussion around the plan for the updated MOPS and the goal was to restart these discussions in Jan 2023.

4. Future Meetings, other business and actions

Next (virtual) joint plenary with Eurocae WG-119 will be on 20Jan2023.

Action: Share updated DO-399/ED-310 document and comments with stakeholders for review once the document has been updated pursuant to addressing outstanding comments.
