Meeting opened 09h05 CEST / 09h05 EDT.

Introduction by Assaf, thanking those members who had contributed to the SP/IR document to date. The purpose for today’s meeting being a final review of the document with aim being that we take a decision to release the draft to Open Consultation / Final Review and Comment

Tour de table – all participants introduced themselves.

Adam reiterated Assaf’s opening comments, thanking those members who had made significant contributions to the document development.

Alex and Karan introduced the EUROCAE and RTCA policy slides.

3. Review Agenda

Agenda as proposed was agreed.

4. Review minutes from Plenary #16 (15-16th June 2023)

Alex reviewed the minutes from meeting #16. Minutes were adopted.


5. Terms of Reference update

The updated terms of reference were briefed to the meeting above agenda item. RTCA PMC and EUROCAE TAC approved the proposals from the WG/SC as expected.

6. SPR/INTEROP for non-cooperative UAS detection systems – Review

The latest version of the document was tabled in the meeting, having been made available to members on 02 August: Accessible via [Aeropus link](#) or  [ED SPR C-UAS_0.20_02AUG2023.docx](#)

Julia spoke to the latest evolution of the document, including a summary of the Chapter structure. It was noted that this would be the first version of the standard and that future revisions were likely, particularly following the WG/SC's review of the OSED (the next task). The document focusses on the detection element, within the C-UAS 'system of systems'.

The document was not reviewed in detail during the course of the meeting.

The document as presented still has a number of unresolved comments that need to be considered by the chapter authors. A good discussion ensued regarding the readiness of the document to proceed to OC/FRAC. Karan explained the RTCA position concerning the approval needed for the 'final' draft to be approved in Plenary; it would not be appropriate for the extent of comments still outstanding to be dealt with before FRAC but after a plenary. It was also noted that the document should not be going to OC/FRAC with the comments still present, and also that any known issues are best resolved before releasing to OC/FRAC.

7. Decision required: Proceed to OC/FRAC for SPR/INTEROP document, and timeline

Options considered:

- 1: Proceed to OC/FRAC with the document as presented to the meeting
- 2: Document editors/chapter leaders to further review comments, with a view to resolving them ahead of a next plenary session which would then approve the document for OC/FRAC. Also opportunity for other WG/SC members to review and make recommendations.

Consensus was for Option 2, with a next plenary meeting set for 21 August 2023.

The kickoff meeting was earlier today, and the outcome will be a CEN Workshop Agreement (a document type used in CEN) within around 1 year.
