RTCA SC-186 Plenary 89 and EUROCAE WG-51 Plenary 86 Meeting Summary

- 1. Chairman Welcome, Introductions, and Remarks
 - Jessie convened the Sept.18, 2023 meeting by welcoming all in attendance.
- 2. RTCA and EUROCAE Policy Presentation
 - Brandi Teel read several standard RTCA policy statements
 - Alex Engel read several standard policy statements from EUROCAE
- 3. Review of Meeting Agenda
 - Jessie reviewed the agenda. No additional agenda items were added.
- 4. Review/Approval of the Last Plenary Meeting Summary
 - The minutes/summary from the April 20, 2023 plenary were posted to AerOpus
 - Doug Willey moved to approve and Lesley Weitz seconded; Meeting Summary was approved.
- 5. Review & Approval to submit deliverable "Summary of ADS-B In Discussion Group Activities" to RTCA and EUROCAE
 - Topic Lead: Lesley Weitz & Nico de Gelder
 - Lesley Weitz and Nico de Gelder presented slides on the deliverable. See presentation in AerOpus. The following topics were covered:

- Proposed updates (Change 1) to DO-317C/ED-194B which include corrections to test vectors, editorial updates for clarification or to remove redundant requirements, updated/new requirements to support CAS for Departures (CAS-D)
- Proposed updates to DO-361A/ED-236A were reviewed. The proposed changes to DO-361A/ED-236A do not warrant a document update at this time.
- Archive of recent research for ADS-B In Operations in the US NAS:
 - Recent research on proposed ATC Automation (for CAS-A and Interval Management operations)
 - Recent benefits analyses
 - AIRS Evaluation Objectives and Results
- Potential applications using ADS-B Weather Messages (ADS-Wx)
 - Recommend updates to DO-317/ED-194 to include applications enabled by ADS-B Wx messages only when operational concepts have been matured
- Johan Martensson asked whether DO-361A FIM MOPS referenced ADS-Wx AIREPS. Answer: they are (in DO-361A Change 1).
- Lesley and Nico indicated that they would be happy to take any questions offline if anyone has further questions after the meeting.
- Motion to send document for PMC approval: Wes Googe and seconded by Steve Darr. The paper is approved and will be sent to EUROCAE and RTCA.
 Jessie thanked the group for their work on the paper.
- 6. Review and Approval of update to SC-186/WG-51 Terms of Reference (ToR)
 - Jessie reviewed the proposed updates to the SC-186 ToR which include:
 - Remove completed white paper deliverable
 - Add new DO-317C Change 1 deliverable—updating test vectors; adding in CDTI CAVS applications and changes to reflect changes in white paper.
 Scope section was updated to reflect planned DO-317C Change 1 updates.
 - Plan is to complete FRAC/OC in April 2024 to be adopted during June PMC. Plan is also for SC-186 to go into Active Monitor status at the June 2024 PMC.
 - Doug Willey (ALPA): ALPA did not agree with proposed language in the ToR regarding updating/adding CAVS requirements to enable CAS-D. The solution was to remove "enable CAS-D" text in the ToR and add "to align with TSO-C195C". This was done during the meeting. Bogdan Petricel and Lesley Weitz suggested that ALPA can also comment on the Change 1 MOPS updates during the FRAC/OC process.
 - EUROCAE WG-51 will also update their ToR to align with the SC-186 ToR.
 - Motion to approve the ToR update to send to PMC in December: Greg Comstock moved and seconded by Nico de Gelder. No objections. SC-186 ToR update was approved to go to the PMC.

- Motion to approve WG-51 ToR for the TAC: Nico de Gelder and no objections.
- 7. Status and Plans for EUROCAE WG-51: ED-129 and ED-142
 - Topic Lead: WG-51 Chair Johan Martensson
 - Johan provided an update on ED-129 (ADS-B) and ED-142 WAM activities. See presentation in AerOpus.
 - WG-51, SG-4 is currently dormant following the work of ED-129C, Technical Specification for a 1090 MHz Extended Squitter ADS-B Surveillance System (to be formally released soon). Work on ED-129D (for CAT053 update) is planned to start in mid-2024 and complete in mid-2026.
 - WG-51, SG-5 Wide Area Multilateration is currently active. The ED-142A Technical Specification for Wide Area Multilateration (WAM) update is planned for completion in mid-2025, and an ED-142B update is planned starting in 2026.
- 8. Other Business
 - No other business

- 10. Schedule Next Plenary Meeting
