#### Tuesday, October 24th Plenary

The Plenary convened at approximately 0900 EDT / 1500 CEST

- 1. Host and Co-Chairs Welcome and Introductions
  - Ed Hahn and John Micallef welcomed participants.
  - Ed managed the participant introductions.
  - Attachment A lists the participants for the Plenary.
- 2. Administrative Matters RTCA & EUROCAE Policies
  - Mark Watson and Rebecca Morrison presented the EUROCAE and RTCA mandatory slides on anti-trust, proprietary/intellectual property, committee participation membership, GDPR privacy policies, and Russian participation prohibition.
- 3. Agenda Review
  - Ed Hahn presented the meeting agenda.
  - Ed asked if there were other agenda items, and none were offered.
- **4.** Approval of Minutes from Plenary #6
  - Clay Barber presented the draft July 27, 2023, plenary minutes noting a few editorial changes since the prior draft was posted to RTCA AerOpus and EUROCAE Workspace.
  - Some real-time adjustments were made to the minutes.
  - The minutes were approved as adjusted.

**Post meeting note**: The final minutes were posted to the July 27, 2023, Plenary Meeting #6 folder on AerOpus and Workspace.

- 5. Review Comment Matrix with Resolutions for ER-028, RR-001
  - Andy Roy noted appreciation for all the work done to complete the surveys and the report.
  - Clay Barber reviewed the comment matrix noting all RAC comments have been resolved.
  - Clay noted a few additional comments were received from the post-RAC draft review.
    - o Garmin and Sai Kalyanaraman proposed changes to the DO-235C Description.
    - o Jessie Turner proposed adding a sentence to reference Figure 2-1 as well as to address a few editorial issues.
  - These comments were discussed and agreed to be incorporated into the final document.

• Ed Hahn walked through the list of comments received from other RTCA/EUROCAE SC/WG members that SC-242/WG-124 had agreed required confirmation that they were resolved. Confirmation was obtained for each of the comments.

#### **6.** Consider a Motion to Publish ER-028, RR-001

- Ed Hahn asked for a motion to publish ER-028, RR-001 with incorporation of post-RAC comments.
- Jessie Turner moved; John Moore seconded.
- The committee approved to publish ER-028, RR-001 with incorporation of post-RAC comments.
- <u>ACTION</u>: Clay Barber to incorporate post-RAC comments into document by COB Oct 24, 2023, and provide back to Rebecca Morrison.
- The committee will request out-of-cycle approval of ER-028, RR-001 so that the report is available to support external groups such as ICAO FSMP, WRC, etc.

#### 7. Date and Venue of Next Meeting

- The committee agreed to have subgroup weekly meetings on Nov 7, 2023, and Nov 14, 2023, after which they will be suspended while WRC 2023 is in session. Subgroup weekly meetings will resume Jan 2, 2024.
- The committee agreed to meet for an in-person Plenary #8 during the week of February 27-29, 2024, at EUROCONTROL (Brussels) with plenary the afternoon of the 29th. There will be a hybrid option.

#### **8.** Any Other Business

- Jessie Turner asked about in person meetings for 2024. Ed Hahn noted his preference for quarterly meetings: two in Europe and two in US (doesn't have to be at RTCA in Washington, DC).
- John Micallef noted the EUROCAE TAC asked if this committee would have bandwidth to implement Subgroup 2 guidance that has sufficient maturity into the SC-239/WG-119 radio altimeter (RA) MOPS.
  - o Ed noted some on this committee are, and will be, heavily involved in developing the RA MOPS, but noted others on this committee may have valuable insight that that can be offered beyond the expertise already in SC-239/WG-119.
  - o Jessie noted that it seems as likely that this committee will learn from SC-239/WG-119 as SC-239/WG-119 will learn from this committee.
  - o Rebecca Morrison noted one potential way to assist is for this committee to be invited to participate in SC-239/WG-119 RAC review(s) of RA MOPS.
  - o **ACTION**: Coordinate with SC-239/WG-119 with objective of being a resource for them including RAC review(s) participation.
- Rebecca noted the Sep 21, 2023, RTCA PMC action to consider changing the title of the Guidance document to avoid confusion with WAIC MOPS title ("wireless").

- o Some potential alternatives were offered but none were agreed.
- o **ACTION**: Committee to consider Guidance document title change during February 27-29, 2024, meeting.

- Review of Open Actions: Clay Barber reviewed the open actions from the July 27, 2023, plenary minutes.
  - o March 20, 2022, Plenary #1:

    - Action 2: It was agreed to keep Action 2 partially open and extend the due date to identify document editors to Plenary Meeting #8.
  - o April 20, 2023, Plenary #5:
    - Action 23: This action will remain open as an ongoing action.
  - o July 27, 2023, Plenary #6:
    - Action 27: It was noted that the additional call for participation remains to be completed.
    - Actions 28, 29, 30, and 31: Agreement to close.
